

**DUNBAR TOWNSHIP  
ORDINANCE NUMBER 1 OF 2020**

AN ORDINANCE AMENDING ORDINANCE NO. 1-87, TO CHANGE THE DAYS AND TIMES DURING WHICH OPEN BURNING IS PERMITTED WITHIN THE TOWNSHIP.

WHEREAS, Dunbar Township, Fayette County, Pennsylvania, has enacted Ordinance No. 1-87, as amended, to regulate the burning of garbage and other materials upon public or private property, except as provided by such ordinance and to fix certain days and hours for burning within the Township;

WHEREAS, the Board of Supervisors of Dunbar Township has concluded that limitations to burning is necessary for the overall health, safety, and welfare of the community;

WHEREAS, the Board of Supervisors of Dunbar Township has concluded that flexibility is needed in establishing the days and hours for burning within the Township in order to address changing conditions within the Township.

NOW, THEREFORE, it is hereby ordained and enacted by the Board of Supervisors of Dunbar Township as follows:

**Section 1. Fires Unlawful at Certain Times; Permit Required for Certain Fires.**

Section II of Ordinance No. 1-87, as amended, shall be amended to delete Section II in its entirety and replacing it as follows:

“It shall be unlawful for any individual, partnership, association, corporation, department, bureau, agency, or other legal entity from and after the effective date of this Ordinance to burn and/or permit to remain burning upon any premises, lot, street, alley or public place within the limits of the Township of Dunbar, any loose, dry papers, leaves or dry combustible materials of non-noxious nature at any time during the day or night, except at such days and times as may be established by the Board of Supervisors of the Township of Dunbar at a regular meeting. Unless otherwise established to the contrary by the Board of Supervisors of the Township of Dunbar, burning in conformity with this section shall be permitted between the hours of 9:00 a.m. and 6:00 p.m., prevailing time, on Monday and Wednesday of each week, and between the hours of 9:00 a.m. until 6:00 p.m., prevailing time, on Saturday of each week. Any change or revision of such hours shall be adopted by ordinance or resolution of the Board of Supervisors of the Township of Dunbar and advertised for the public in a newspaper of general circulation.”

**Section 2. Severability.**

It is herein declared that the provisions of this Ordinance are severable, and if any provisions, portions, or sections of this Ordinance are declared to be illegal, invalid, or unconstitutional, the decisions of any court or competent jurisdiction, which makes declarations, shall not impair or affect any of the remaining portions of this Ordinance.

**Section 3. Repealer.**

All ordinances, resolutions, or parts of ordinances or resolutions inconsistent with this ordinance are hereby repealed in so far as they conflict with this ordinance.


**Section 4. Effective Date.**
